LITCHFIELD GRANGE CHARTER RESTORED

After being dormant for more than two years, the Litchfield Grange is back in business with 14 new members eager to restore the organization as a key part of the community.

A recruiting drive that began during the summer concluded in late November with the new members receiving the Grange's charter — which had been suspended — from Connecticut State Grange Vice President George Russell.

The new members are James Fischer, Andrew Graves, Lynne Alexander, Karl Ebner, Barbara Putnam and Jonathan Wilson, all of Litchfield; Joan Spear of Bantam; Deneen Bernier of Northfield; Richard Grinvalsky of Morris; Jessica Falwell of Warren; Carol Prescott and Richard Prescott of Thomaston; Alicia North of Cornwall; and Deborah Laws of Winsted.

Several of the members are well-known locally for their community involvement. Fischer is a wildlife biologist and researcher at the White Memorial Conservation Center; Alexander is the president of the Litchfield-Morris Rotary Club; Putnam and Grinvalsky are organic farmers, and Wilson is a business leader in the center of town.

Thirteen new members were needed for the Grange's charter to be reinstated by the state Grange, which assumed management of the Grange's hall on Bantam Road after the Grange closed.

The state Grange is providing resources and a mentor to help the organization grow. Todd Gelineau, secretary of the state Grange and a member of Winchester Grange, is serving as mentor. Gelineau led the summer recruitment effort.

The Litchfield Grange was established in 1889 as a support organization for local farmers. It evolved into an organization focusing on community service and held an annual agricultural fair and other events to raise money for its scholarship fund.

A meeting of the new Grange will be held Jan. 8 at 7 p.m. at the hall. Officers will be elected and there will be a discussion about fundraising, community service projects and the idea of establishing a buyers club within the Grange. Several of the new members were part of the former Litchfield Corner Co-Op that sold the products of local growers. Since the Grange has had a long tradition of supporting cooperatives, incorporating a co-op into the structure of the new Grange would be a natural, Gelineau said.

Anyone interested in joining the Grange is welcome to attend the Jan. 8 meeting.

Legislatively Speaking

Happy New Year to all. We are off to another Connecticut Legislative Session which starts on January 7, 2015. Gordon Gibson will again be in Hartford communicating our views on the different issues. Our Legislative Guide should be out soon. We will be sending a copy to all of the State General Assembly members and the Governors and Lt. Governors offices. Connecticut Granges will also be receiving a copy. I encourage you all to review a copy when it is received. We all need to be become aware of issues that members of the Grange have brought forward to the State Grange and have been set as Grange policy.

I spotted an interesting topic in my local newspaper. The article was originally printed in the Republic-American newspaper. Todd also saw the same article and it was re-printed in the December Granger as well. The topic was on possible regulations concerning 'local' or 'locally-grown' farm produce sold in farm stands. Farm stands have been increasing in popularity in the past few years with more consumers concerned about the quality and freshness of

the food they eat.

Some citizens have been expressing concern about products that are being sold at local farm stands. In order to operate a Local farm stand the farmer must obtain a \$90.00 local zoning permit. They usually are selling produce from their own farm. Many are also adding products from neighboring farms. These farm stands are not subject to the Connecticut farmer's market rules which require farmers to only sell what they grow. It is legal to sell produce grown by other farmers in their local farm stand.

This article brought up the subject of what is the definition of 'local'. The article did not have a definition of 'local' and there were a wide variety of discussions on what 'local' meant. One thought it was within a 75 mile radius. There is a Connecticut Statute that addresses the definition. Sec. 22-38 addresses 'local' and 'locally-grown'. Section (b) states that "Farm products grown or produced within a ten-mile radius of the point of sale for such farm products may be advertised or sold in Connecticut as 'Native', 'Native-Grown', 'Local', or 'Locally-Grown.'" The statute also defines 'Connecticut-Grown' as only those farm products that have been grown in the State of Connecticut. If you have a farm on the border of the state and sell locally-grown items from a farm right over the state line you cannot advertise those products at 'Connecticut-

Grown' but they could be considered 'locally-grown' if they are grown within a 10 mile radius.

Some residents have expressed concerns that they have not been made aware that the produce they are purchasing from

local farm stands have not been grown on the farm where the stand is located. There is a suggestion that farm stands be required to label those products which are grown by neighboring farms with the name of the farm where the product

originated. The state Department of Agriculture supports legislation requiring labeling of products from neighboring farms. According to the article, farm stand operators are not opposed to such a suggestion.

A few simple steps

Our new State Master has charged me, Maggie Buck and Ted Beebe with Membership Growth in Connecticut. It is our goal to offer thought provoking articles and tips that will have you thinking differently about your Grange and how together we grow.

The State Grange cannot change the makeup of the membership in your Grange, sorry, there is no magic wand to be waved or pill that can be taken, but what we can do to help change your course from stagnation and complacency to excitement and growth is to offer a few very simple steps to consider using at one of your next Grange meeting, perhaps as a Lecturer's Program. - 100 new members this year!
- Leadership Growth
- Well, you knew I couldn't write an article and not mention this category, after all if we don't develop better leadership skills how will we recruit, mentor and develop our 100 new members into Grange Members?


Step Three: Go over your list for feasibility. A disco ball would be cool, but disco died a long time ago. A goal of 100 new members may not be realistic, but 5 or 10 this year is. Set goals your current membership can obtain and be careful to not choose too many. Two or three goals should be good for almost every Grange; after all we want to set ourselves up for success.

Step Four: Set up teams of energetic and enthusiastic members that can see these dreams becoming reality. Set a time line for each to develop and execute their plan(s). Have each team report at each meeting on their results to date. Make sure you celebrate the successes of each team every month. If a team has made no progress discuss how, as a group, you can get the "plan" back on track. Encourage each member to be part of the process, NEVER, NEVER, NEVER scold, reprimand, criticize or "take over" the plan or team members because it is not going the way you think it should. That is counterproductive and in a complete opposite mindset of collective participation. Constructive input can be a gift to the team and the process, negative input only builds higher walls and discourages future participation.

Step Five: Enjoy your results, have fun at your new activities, enjoy your new members and your Granges renewed positive energy.



GLEANINGS FROM YOUR STATE PUBLIC RELATIONS TEAM

A New Year - A New Approach

2015 is a new year - and a new opportunity to get your Grange into the eyes of the community. Here's a few tips to keep in mind when planning out your upcoming Grange year.

- **Make your community aware that the Grange exists - tell your Grange story.**

Granges have a number of avenues available at their fingertips to promote their events and activities - such as press releases to the local media, social media outlets like Facebook, and more traditional methods like posters, signage, and even face-to-face and telephone communications. But when promoting your Grange, are you telling its story? How many years has your Grange been organized? Are there specific projects/events that your Grange is known for (like your Fair, Bazaar, Community Service projects, etc.)? Be sure to take every opportunity to tell your Grange story. It can be as easy as a paragraph at the end of a press release, a "throw-back Thursday photo posted to Facebook, or a line at the bottom of poster.

- **Be proactive. Don't wait for publicity to come to you.**

Media outlets are busy places. They have hundreds of organizations just like the Grange vying for space and airtime. Chances are, they will not just stumble upon your Grange and promote it - you have to initiate the contact. Invite the media to a Grange meeting or event. Send a quick e-mail to your local newspaper promoting your upcoming activities - just be sure to give them at minimum 2-3 weeks notice. Even a quick phone call can be the difference between press coverage vs. no press coverage.

- **Simplify your approach and weed through the clutter.**

Promoting your Grange can be overwhelming when you don't know what

direction to turn first. You have a list of newspapers, a Facebook Page you are not comfortable using, and no real computer skills to speak of - so where do you start? Begin by taking a step back, and selecting one path on which to concentrate your efforts. Once you feel confident in writing press releases, then move on to adding Facebook to the mix. Try taking a computer class to learn the basics. Most towns offer beginner computer classes either for free or for a small fee through adult ed or the senior centers. Look into your options, take it one step at a time, and eliminate the frustration.

- **Be organized and prepared.**

In order to go the extra mile when promoting your Grange, you need to be knowledgeable of the organization, ready to answer any questions that may arise, and be armed with the details. When writing your press releases and announcements, try to include as much relevant information as available. This includes writing your Grange column for the Connecticut Granger. We've all read the reports that announce the Grange's latest fun event, but leave out important details, like time and cost. Don't let the reader guess - tell them everything they need to know upfront.

Staying organized is the key to success. Keep a log of when you submit press releases, and set reminders in your calendar for follow-up. Schedule your Facebook posts in advance, so that your page is updated consistently. Create a folder in your e-mail to save important messages avoiding accidental deletion. Keep print-outs in a 3-ring binder of your publicity efforts for each event. No matter the method(s) you choose, effective organization efficiently creates results.


Public Relations can play an integral part in your Grange's journey. Be sure to utilize available resources and most importantly, set achievable goals to build toward.

It was a cold rainy night, but we were able to hold our December Christmas meeting. Like Pomona, this is not always possible. A holiday program was enjoyed along with the annual grab bag gift exchange.

The second vote was held at this meeting to amend our by-laws to allow our dues to increase correspondingly whenever dues at State or National Grange increase. A \$2.00 dues increase was passed by National Grange this past November, meaning our dues payments will increase 50 cents per member each quarter next year. Our finances are already thin, so \$2 per member would be impossible for us to absorb without an increase. We hope all of our members understand that Winchester Grange has not increased the amount of dues money

staying with Winchester Grange since the boiler needed replacement several years ago. All dues increases since then have been required by and paid to National Grange—completely out of our control. We appreciate the support and understanding of all of our members. - Paprika





Strawberry Cupcakes with Strawberry Icing

2015 CWA Baking Contest Recipe

Ingredients:


3/4 Cup strawberries, sliced in half
1 teaspoon baking powder
1/4 Cup milk
1 Cup sugar
2 large egg whites

1-1/2 Cups flour
1/4 teaspoon salt
1/2 Cup unsalted butter
1 large egg
1 tsp. vanilla (optional)

For Frosting:

2 Tablespoons strawberries, pureed
2 Cups powdered sugar
dash salt

1/2 Cup unsalted butter
1/4 teaspoon vanilla



Directions:

Preheat oven to 350°. Line muffin pan with 12 paper liners. In medium bowl combine flour, baking powder & salt, set aside. In a food processor or blender add the strawberries and process until pureed. Put 1/3 cup of strawberries into measuring cup and set aside. Add rest of strawberries to a small bowl to be used in frosting. In mixer, cream butter until light and fluffy. Gradually add sugar and mix till well blended. Reduce speed and slowly add egg & egg whites. Blend well. Add vanilla. Mix milk and 1/3 cup of puree. Alternate flour and milk mixture to mixer slowly ending with flour. Scrape bowl often and continue to blend. Pour batter evenly into prepared muffin cups. Bake 20-25 minutes or until lightly browned. Cool completely before frosting.

FROSTING: Soften butter in bowl, add salt and then beat in mixer until very fluffy. Reduce speed and add powdered sugar and blend well. Add vanilla and 2 tablespoons of puree. Mix thoroughly. Ice the cupcakes. For judging, submit three on a paper plate. Put your name and Grange number on the back of the plate.

CSG Past Deputies Association



Act Quickly on Tax Extenders



The United States Senate, on a bipartisan vote of 76-16, extended about 50 expired tax code provisions. President Obama is expected to quickly sign the extender package. These extenders are retroactive for 2014 only and taxpayers have 15 days to decide if and how to use these tax breaks. The retroactive extension means tax payers will be operating under an expired tax code again in 2015. Grangers should consult their accountants and tax preparers immediately to determine how to best take advantage of these extenders for 2014.

Here are a few of the tax breaks you may be most interested in:

- Section 179 - Allows a higher deduction (up to \$500,000) on capital expenditures like machinery and equipment.
- Bonus depreciation - Extends the faster rate of depreciation for agriculture producers

- Biodiesel - Continues the \$1/gallon tax credit for biodiesel production
- Wind energy - Continues the wind energy tax credit
- Research and Development - Continues popular credits for research and development
- Distressed areas - Includes an incentive for businesses to invest in economically depressed areas
- The disabled - People with disabilities may now open tax-free savings accounts (new provision)
- Sales taxes - Allows a sales tax deduction for residents of states that have no income tax
- Charitable contributions - Senior citizens may exclude from their income up to \$100,000 in charitable donations from their retirement accounts
- "Pork" - Several special preferences to entities important to certain members of Congress

The 113th Congress, one of the most unproductive and least popular in history, is now over. Only about 280 bills have become law the last two years, the lowest number in 20 years. The 114th Congress begins January 6, 2015.

Chaplain's Message

The month of January gets its name from the Roman god Janus, who had two faces, one looking forward and one looking back. In our Grange ritual the Overseer in the fourth degree gives the charge, "Cultivate the habit of looking for better and brighter days, instead of mourning over the past." Notice the use of the word "habit".

This is the time of year when many of us make New Year's resolutions, in many cases resolving to correct imperfections in our behavior or habits, such as resolving to lose weight or quit smoking, or finally to get around to cleaning out the garage [I resolved to do this five years in a row before I finally got around to doing it].

But just as important as trying to change those habits which affect our physical well-being is trying to change those habits which affect those with whom we come in contact. Do other people find you to be someone who is enjoyable to be around, or do they find you morose or argumentative or constantly complaining? Scattered throughout our Grange ritual are reminders about how we should interact with other people. In the same Overseer's charge which I mentioned at the beginning of this article is the further instruction, "While you strive to make labor honorable, exert yourself to make it pleasant and cheerful for all around you."

But are my life-long habits unbreakable? Can I change? Can I resist the temptation to return to my old habits? St. Paul in his first letter to the Corinthians says: "No temptation has overtaken you except what is common to mankind. And God is faithful; he will not let you be tempted beyond what you can bear. But when you are tempted, he will also provide a way out so that you can endure it."

And in Paul's letter to the Ephesians: "You were taught, with regard to your former way of life, to put off your old self, which is being corrupted by its deceitful desires; to be made new in the attitude of your minds; and to put on the new self, created to be like God in true righteousness and holiness."

So let us resolve, in this coming year, not only to shed our old bad habits but also to cultivate new and better habits, especially in the attitudes we use when we interact with other people.
