

The political season for the next Presidential election has started. We have already seen a multiple of people in both parties announce their intentions to run for the position. Debates have also already started.

Coming up a lot sooner, but not getting the publicity that it should is our local town elections. Many towns in Connecticut will have elections in November this year. These elections will select your First Selectman or Mayors, according to which type of government your town has. You will also elect the selectman, registrars of voters, school boards, zoning and other local elected positions. Connecticut town political parties have already held their caucuses and have selected their candidates for these local elections. Since this is a non-presidential and non-state election year, we will not seeing the ads and signs for the local state representatives and senators. Around the end of the month you may see some local signs appear and get a few mailings.

I have heard it said that 'this is only a local election. It is not important' or 'I don't bother voting in local elections, they are not important'. This could not be further from the truth. These are the people who will be running your town and town affairs for the coming two years. They determine your taxes, and what they are spent on. How your schools are run. They keep the towns and cities running. Without them, towns would not have the services that we all depend on. Your elected Town Clerk takes care of marriage licenses, dog licenses, records of property transactions and a multiple of other things. School boards keep your schools running. They hire personnel, keep the school buildings open and curriculum up to date. Your social service agencies take care of elderly, persons needing rides to doctors and persons in needs of additional care. "It's a pretty good event," commented Reilly.


Town Green was the only place where one could find the forest fire prevention Smokey character Bear along with fine artists as well as live rock music.

Resolutions for the 131st Annual Session of the CSG

1) RE: LATE FEES ON QUARTERLY REPORTS

WHEREAS the delegates to the 129th Annual Session of the Connecticut State Grange adopted a resolution that assesses "all Community and Subordinate Granges that fail to remit their quarterly dues within (30) days of the due date a late fee of one (1%) per cent per month until the dues are received by the Connecticut State Grange," and

WHEREAS this policy has been enforced by the Secretary and Treasurer of the Connecticut State Grange with limited success as many Granges simply submit their regular payment without the fee or have to be billed again for the fee, and

WHEREAS the cost of this fee in most cases is not much more than \$1.00, and

WHEREAS the cost of postage to send out the invoice and for the Granges to send back payment eats up nearly all of the fee, and

WHEREAS this fee has not served as a deterrence as the same number of Granges seem to be chronically late with their reports, and

WHEREAS late quarterly reports not only pose a financial burden to the State Grange but they also negatively affect the accuracy of our membership numbers which are used in many different ways that also include assessments by the National Grange.

THEREFORE BE IT RESOLVED the 1% late fee be abolished and replaced with a flat \$25.00 fee assessed 30 days from the close of the quarter on all late payments, and

BE IT FURTHER RESOLVED this fee commence with reports due at the close of the December 31, 2015 quarter.

2) RE: REPEALING THE TAX ON GAME BIRDS

WHEREAS the State of Connecticut taxes farmers that sell game birds like pheasant, chucker and quail, and

WHEREAS the State of Connecticut does not tax farmers that sell ducks, chickens and other birds, and

WHEREAS the State of Connecticut is only getting taxes from the four game breeder with licenses.

THEREFORE BE IT RESOLVED we ask that the State of Connecticut repeal the tax on game birds because on the face of it, it is discriminatory. It treats one group of farmers differently from others.

3) RE: RETURNING TOLLS ON CONNECTICUT INTERSTATE HIGHWAYS WHEREAS this law created a dedicated fund that supports four sectors, Agriculture, Open Space Conservation, Affordable Housing and Historic Preservation, and

WHEREAS funding for these programs originates from a \$40.00 surcharge on real estate recording fees, and

WHEREAS the CIA program has been generating up to \$25 million per year with the monies being placed in a dedicated fund, and

WHEREAS the CIA fund was created so that it was not part of the budget and would always be available for the particular programs, and

WHEREAS this CIA has been extremely successful directing more than \$133 million towards saving hundreds of acres of farmlands, restoring historic buildings, supporting agricultural programs and affordable housing, and

WHEREAS this last year Governor Malloy proposed in his budget to divert any currently unspent money from the CIA fund as well as any income going to this fund through 2017 to the general fund.

THEREFORE BE IT RESOLVED that the Connecticut State Grange oppose any diversion of the Community Investment Funds to the general fund, and

BE IT FURTHER RESOLVED that the Connecticut State Grange encourage the Connecticut General Assembly to maintain full funding of the Community Investment Act.

5) RE: FEDERAL ROAD GUIDELINES

WHEREAS when using Federal Assistance to repair infrastructure the rules are stringent, such as having to put in a 32 foot wide bridge with lights over a stream that has a dirt road on each side of the bridge and no other street lights, and

WHEREAS these strict standards have caused towns to turn down the Federal Assistance Funds causing additional taxes to small towns.

THEREFORE BE IT RESOLVED that the Grange support changes to the Federal Guidelines for using Transportation Funds which will allow for exceptions to the standards when it can be shown that these exceptions will not produce new major safety concerns.

6) RE: ROAD & BRIDGE REPAIR

WHEREAS there have been numerous reports outlining the poor condition and repair of Connecticut roads and bridges, and and rural State roads and assistance to towns to repair their roads.

7) RE: GRANGE MAILING LISTS

WHEREAS Section 8.10.1 of the National Digest reads "Secretaries of State Granges shall be required to send updated mailing lists on an annual basis to the National Grange on or before June 30th each year, and

WHEREAS the Digest does not place any limitations on the use of these mailing lists once sent to the National Grange, and

WHEREAS the Connecticut State Grange already prohibits the use of State Grange publications (namely the State Directory) for these purposes, and

WHEREAS many Grange members are concerned about their personal information being distributed, sold or utilized for marketing purposes, and

WHEREAS the National Grange has added a feature to their website where members can individually "opt out" of the mailing list distribution, and

WHEREAS members who do not have access to the internet or knowledge of its use are at a disadvantage.

THEREFORE BE IT RESOLVED that the Connecticut State Grange be prohibited from selling or utilizing mailing lists provided by the Community Granges for non-Grange marketing purposes, and

BE IT FURTHER RESOLVED that the National Grange be prohibited from selling or utilizing lists provided by the State Granges for non-Grange marketing purposes.

8) RE: NATIONAL PROGRAMS

WHEREAS the expenses of the National Grange continue to mount while programs and services to the State, Pomona and Community Granges have declined, and

WHEREAS staffing at the National level has declined to a point that cannot support the needs of the Granges throughout the country, and

WHEREAS the National Grange has passed dues increases based upon the falling financial stability of the National Grange.

THEREFORE BE IT RESOLVED that 50% of any future dues increases passed at the National level beginning with the 2015 National Session in Lincoln, Nebraska, be earmarked and allocated to programs in place or designed to build and strengthen the Grange throughout the country.

WHEREAS use of financial support should also be closely monitored to ensure the children's welfare.

THEREFORE BE IT RESOLVED that the Connecticut State Grange go on record supporting and encouraging efforts to change the way courts handle visitation and protection orders to encompass the welfare of all children within each home and to provide the necessary time to heal before any possibility of resuming contact with the offending parent.

10) RE: HEROIN EPIDEMIC

WHEREAS heroin and opiate addiction has increased to epidemic levels statewide, and

WHEREAS heroin and opiates are relatively inexpensive and are widely available, and

WHEREAS the growing numbers of overdoses and deaths resulting from use of these drugs are not limited to one economic or social group, and

WHEREAS according to the office of Senator Blumenthal, there were 195 fatal heroin, morphine or codeine overdoses in the State of Connecticut in 2012, and

WHEREAS those numbers have increased to 284 in 2013 and 347 in 2014, and

WHEREAS the number of overdoses nationwide have quadrupled in the last ten years, and

WHEREAS in the City of Torrington there have been over 24 documented overdoses in the last three years, and

WHEREAS larger cities like Torrington have resources available to them for treatment while smaller towns do, not have the same accessibility, and

WHEREAS even when a patient goes through a 28-day in-patient program and their detox is done, they remain at a very high risk of overdose as their bodies are not capable of handling the large doses of these drugs they were taking prior to treatment, and

WHEREAS all local leaders agree that a united regional approach is needed to combat this epidemic.

THEREFORE BE IT RESOLVED that the Connecticut State Grange voice our support and provide any and all encouragement needed to develop regional approaches to combating herion and opiate addiction in this state.

11) HANDICAPPED ACCESSIBLITY FUNDING

WHEREAS many Granges meet in their own hall in which adequate access for handicapped individuals is lacking, and 1] Devise a process for grant application including design of an application form which specifies: clear plans and justification for structural changes, which are not to be cosmetic or repair related, but specific to promoting handicap accessibility, proposed budget and timeline, and if needed, evidence of local "code" approvals prior to initiating projects and format for submission of application.

2] Review applications

3] Select recipients and notify

4] Determine criteria for successful completion of the project, including a timeline

5] Determine criteria for possibility for unsuccessful completion and potential need for return of grant money.

When the project is successfully completed and approved, including passing any required inspections, the funds would not need to be repaid. The funding would be awarded such that if awarded, the same Grange could not reapply until a five year period has passed. The total amount of \$30,000 in one year could be divided between one to three Granges.

12) RE: ELECTRONIC BANKING RECORDS

WHEREAS the Deputy has the responsibility to review financial records at the annual inspection of Subordinate (or Community) Granges, and

WHEREAS the Subordinate/ Community Granges must present the fiscal year's records in an organized format, including representation of the income, expenses and any other financial activities, and

WHEREAS many Granges are converting to use of electronic banking records, such as savings, checking and CD's, and

WHEREAS electronic banking records provided have tended to show "end of year" results and not monthly fiscal activity, and

WHEREAS by being limited to reviewing only the "bottom line" statements of assets and liabilities, the inspecting Deputy does not have adequate information to properly conduct the required annual financial review, and

WHEREAS it is likely that more and more Granges will be converting to electronic banking practices.

THEREFORE BE IT RESOLVED that the Connecticut State Grange establish a policy requiring that Granges using electronic banking must provide a hard copy of monthly statements, along with the annual end statement, to enable the inspecting Deputy and any other concerned parties, to review income and expenses on a monthly basis and over the course of a year.

WHEREAS many roads in Connecticut are in need of repairs and the state is struggling to care for its infrastructure, and

BE IT FURTHER RESOLVED that the money received from these tolls be directed into a fund for improving our state's infrastructure.

4) MAINTAINING THE COMMUNITY INVESTMENT FUNDS

WHEREAS in 2005 legislation was passed creating the Community Investment Act (CIA), and

WHEREAS money has continued to be transferred from the Special Transportation Fund to the General Fund, and

WHEREAS large sums of transportation fund money has gone to special mass transit projects such as the New Britain Bus only lanes which has little benefit to the rural areas of the state, and

WHEREAS there is discussion of expanding the bus only lanes to east of the Connecticut River.

THEREFORE BE IT RESOLVED that the Grange support no longer allowing the transfer of funds from the Special Transportation Fund to the General Fund and the difference in the General Fund income be offset by budget cuts and not new taxes, and

BE IT FURTHER RESOLVED that the number one priority for Special Transportation Funds be the repair of our crumbling highway system with an emphasis on bridge repair, and

BE IT FURTHER RESOLVED that this emphasis include secondary

MASTER'S ADDRESS

9) RE: PROTECTION OF CHILDREN

WHEREAS abuse of children within the family/home may occur, and

WHEREAS when one or more children are abused in the home, other minors in the home may receive unequal or no protection from the abusing parent(s), and

WHEREAS courts have been known to order visitation for the children who were not abused causing immeasurable emotional trauma for all children and family members involved, and

WHEREAS these visitations have been known to be ordered while the offending parent still may be incarcerated, and

WHEREAS it is imperative that the courts look out for the welfare of all children as they are all severely affected by these traumatic events in their lives, and ana

WHEREAS Granges currently have active members with special needs for building access and use, and

WHEREAS Granges are attempting to recruit new members and need to consider accessibility, and

WHEREAS many Granges rely on income from renting space to the public, which also needs consideration of building access and use, and

WHEREAS improvements, renovations, or new structures may be necessary for entry and exit, stair use and bathroom use, and

WHEREAS individual Grange budgets are limited for necessary architectural or functional use changes.

THEREFORE BE IT RESOLVED that the Connecticut State Grange (Foundation?) develop a procedure for providing an annual grant of a total of \$30,000 to be distributed to one to three Granges, and appoint a standing committee whose responsibility will be to:

13) RE: JURISDICTION OF EAST CENTRAL & MOUNTAIN COUNTY POMONAS

WHEREAS with the closing of Farmington Valley Pomona #11 and North Central Pomona #13 the jurisdictions of East Central Pomona #3 and Mountain County Pomona #4 have changed, and

WHEREAS it is necessary to update the jurisdictions of these Pomonas to include towns within their areas that do not currently have Granges.

THEREFORE BE IT RESOLVED that the jurisdiction of East Central Pomona #3 now include the following towns with and without active Granges: Granby, East Granby, Simsbury, Avon, Farmington, Glastonbury, East Hartford, Hartford, West Hartford, Bloomfield, Windsor, East Windsor, South Windsor, Windsor Locks, Manchester, Bolton, Vernon, Tolland, Ellington, Suffield, Enfield, Somers, Stafford, Coventry,

Andover, and Hebron, and

BE IT FURTHER RESOLVED that the jurisdiction of Mountain County Pomona #4 now include the following towns with and without active Granges: Salisbury, North Canaan, Canaan, Norfolk Colebrook, Hartland, Barkhamsted, Canton, New Hartford, Torrington, Winchester, Goshen, Cornwall, Sharon, Kent, Warren, Litchfield & Northfield, Harwinton, Burlington, Plymouth, Thomaston, and Morris.

WHEREAS members taking the Welcome Ceremony and Obligation, do not follow up by witnessing the Four Degrees, and

WHEREAS by missing the Four Degrees they have missed valuable lessons needed to be good Grangers and officers.

THEREFORE BE IT RESOLVED that the National Grange record a full and complete set of degree conferrals, minus the unwritten work, a Junior Grange section and the First, Second, Third and Fourth Degrees to be used for educational purposes, and aid in conferring those degrees.

WHEREAS drinking ocean water when lost at sea, or stagnant water when lost at land, will sicken and often kill a person, and

THEREFORE BE IT RESOLVED that the Grange urge our legislators to enact laws to require urine saving devices with instructions included in all life saving and medical kits, and

BE IT FURTHER RESOLVED that the military be required to include these instructions in their survival kits.

23) RE: EMISSIONS

WHEREAS the Connecticut Department of Motor Vehicles requires an emission test on older vehicles (up to 25 years), and

WHEREAS the ability to read the mileage (odometer reading) from the vehicle's speedometer is a reason to receive a Turn-Away Document which means the emissions test could not be done and

WHEREAS within 30 days, the problem must be corrected and a new test completed, and

WHEREAS on a few of the older vehicles, the transmission indicator, mileage (odometer reading) and trip mileage is illuminated by a background light, and

WHEREAS if this background light fails to function, the mileage (odometer reading) is not visible, and a Turn-Away Document is issued, and

WHEREAS the mileage is not a factor in the inspection as the year of the vehicle determines when an inspection is required, and

WHEREAS the expense of fixing the problem to restore the light is expensive, approximately \$500.00.

THEREFORE BE IT RESOLVED that the mileage (odometer reading) now required for an emission inspection be optional and not a mandatory requirement.

24) RE: INCOME TAX

WHEREAS the State of Connecticut has a state income tax, and

WHEREAS the completed tax form can be filed either electronically or by U.S. Mail. and

WHEREAS there is no fee for filing the completed income tax form by U.S. Mail, and

WHEREAS if a refund check is due, it takes several weeks before the check is received, and







Need help? The Public Relations Committee is ready to lend a hand. All we ask is that you give us plenty of advance notice to ensure we can fulfill your needs.





Bryon Rider mentioned that he had had many offers to sell his pristine vehicle that cost \$130,000 to renew, but he will not sell. "I won't part with it," he said. "It's got only 44,000 new miles on it."

A few feet away, Peter Hurlbut and Kevin LeMere, both of Winsted and known as the music duo Kevin & Pete, performed classic rock and country songs in the gazebo, leading off with a plaintive version of the 1948 Stan Jones song "Ghost Riders in the Sky."

According to town accounts, Winchester was settled in 1732 and incorporated in 1771. Winchester contains within its borders the city of Winsted, which was named for the towns of Winchester and Barkhamsted. Winchester had been a major producer of mechanical clocks in the early 20th century. Today the town is famous for its wellpreserved 19th-century architecture.

Down the road in a booth outside the historic Winchester Grange building, volunteer Faith Maus and her twins Noelle and Quinlan, both 8, gave out booklets to children for a "passport scavenger hunt" in which participants were encouraged to find secret words like "Art" displayed along each stop of the day's events and get their booklet stamped when they found it.

"There are good things happening at the Grange," Maus said. "There is something for everyone here. Too often it was just for mom and dad but now, there are activities for kids, too."

Maus' twins said they enjoyed playing in the nearby Fire Department's firefighting foam display demonstrations on the corner of the Town Green. "I was totally covered with foam," said Quinlan. "Even my face was!"

Meanwhile, Jim Malloy, 6, and his older brother Jonas, 8, both of Winchester, dove into a fresh pile of fenced-in foam. Fire Chief Peter Marchand, who supervised the activities, said, "It's been a steady stream of people all day. It's a perfect day and a paintings of landscapes. "They're doing a nice job," Bengston said. "I've been attending these events since the 1950s. It's good to see friends out today."

DaleParsons-Marchione, 84, of Winchester showed his large Summer Garden Series oil paintings hanging on the walls. "I am a gardener, and I like capturing different conditions of the flowers that are affecting," he said.

Dick Matthews of Winchester exhibited his pastel paintings at a table along with his wife Toni's wood art. The Matthews, who divide their time between Winchester and California, said they had participated in the town event for the past 15 years.

"It is so much fun," said Toni Matthews. "It's so good to see multiple artists in town and have so much talent shared with the world."

Gary Jordano of Winchester had on his table his ceramic creations, like "spoon rests," bowls, and vases. There was also a hand-crafted slate rock sculpture sporting the Japanese symbol for "eternity" written in 23-carat gold leaf. "I made this for my son's wedding," Jordano pointed out. "I'm borrowing it back for this event."

Across the Town Green the Winchester Center Congregational Church held children's games and sold fried dough and popcorn on the law. Across the road, outside the Historical Association building, Goshen First Selectman Robert Valentine of The Village Blacksmith Shop in Goshen gave blacksmith demonstrations. Hammering a red-hot wrought-iron rod that had been heated over a fire, Valentine fashioned a rose sculpture as well as several steel latchkey fixtures.

Diane Newth of Winchester and her granddaughter Anna Flint, 4, stood nearby and watched in fascination. Flint said, "I want to take a ride in the fire truck next!"

"I'd always wanted to find out about the town's history," Newth said. "Having our granddaughter with us gives us a reason to learn about it."

The Grange was the site for the new Art Show which featured a dozen area artists





Hearty Beef Stew

Fall is officially here, and as the weather cools off, stews and soups are back on the dinner menu. Stew would be a great addition to any potluck supper. Colorful, hearty and tender, this recipe from Campbell's Kitchen for Slow-Cooked Stew features all the traditional ingredients of a good beef stew: beef, carrots, onion, potatoes, peas in a rich gravy. $1 \frac{1}{2}$ pounds beef for stew, cut into 1-inch pieces

- 1/8 teaspoon ground black pepper
- 1/4 cup all-purpose flour
- 1 tablespoon vegetable oil
- 1 pound medium white potato, cut into cubes (about 3 cups)
- 4 medium carrots, peeled and sliced (about 2 cups)
- 2 medium onions, cut into wedges
- 4 cloves garlic, minced
- 3 1/4 cups Swanson® Beef Broth or Swanson® Beef Stock
- 1 tablespoon Worcestershire sauce
- 1 teaspoon dried thyme, crushed

1 bay leaf

1 cup thawed frozen peas

Season the beef with black pepper. Coat the beef with 2 tablespoons flour. Heat the oil in a 10-inch skillet over medium-high heat. Add the beef in 2 batches and cook until it's well browned, stirring often.

Place the potatoes, carrots, onions and garlic into a 5quart slow cooker. Top with the beef. Add 3 cups broth, Worcestershire, thyme and bay leaf. Cover and cook on LOW for 10 to 11 hours or until the beef is fork-tender. Remove and discard the bay leaf.

Stir the remaining flour and broth in a small bowl until the mixture is smooth. Stir the flour mixture and peas in the cooker. Increase the heat to HIGH. Cover and cook for 15 minutes or until the mixture boils and thickens.




Dec 5: Holiday Market (10 - 3)

be a tad bit ambitious, but another one may be on the horizon. About 20 kids enjoyed the mystery ride.





October 31 is Halloween. Most people seem to forget that this was originally a religious holiday. It is the All Hallows Evening before All Hallows Day, or All Saints Day, an ancient festival observed at various times in the early Church, but regularized somewhere around 800 A.D. as being on November 1st. Later it became customary to recognize November 2nd as All Souls Day, so that the three days formed a "triduum".

The fundamental belief behind all three days is that there is a spiritual bond, or communion, between those who have died and gone to heaven and those of us who are still living. We are reminded of this when we recite the Apostle's Creed and affirm that we believe in the communion of saints. The exact nature of this "communion of saints" has been argued among the various Christian denominations for centuries, although most agree that it exists. And indeed it is a comfort to know that our friends and family who have passed to "that great grange above" are not completely cut off from those of us left behind. Also, there exists a spiritual bond among all of us Christians still on earth, as explained in the twelfth chapter of Paul's letter to the Corinthians, because "Just as a body, though one, has many parts, but all its many parts form one body, so it is with Christ. For we were all baptized by one Spirit so as to form one body-whether Jews or Gentiles, slave or free-and we were all given the one Spirit to drink."

Getting back to Halloween, one might ask what is the connection between all this and the children running around from door to door, dressed as witches and skeletons and spiders and such, and reciting "trick or treat". Sam Portaro (1998) states that "In the carnival celebrations of All Hallows' Eve our ancestors used the most powerful weapon in the human arsenal, the power of humor and ridicule to confront the power of death." Thus, dressing up in costumes representing scary things is a way of thumbing our nose at evil and death. This is a great prelude to All Saints day, where we celebrate the victory of goodness over Satan and all his works. What about "trick-or-treat"? This has its origins in a custom from late medieval times, called "souling", where on the eves of All Saints Day and of All Souls Day children and poor people would dress up in costumes, and go from door to door, begging for "soul cakes" in return for praying for the dead. The custom is mentioned by Shakespeare in his play "The Two Gentlemen of Verona". Somewhere in the 19th century this evolved into our familiar "trick-or-treat".

By this time it is probably impossible to restore the religious tradition behind the celebration of Halloween, but when the little imps, witches, devils, skeletons, and Darth Vader show up on your doorstep it won't hurt to give yourself a reminder of how this all started.
